MEMORANDUM OF UNDERSTANDING BETWEEN DEPARTMENT OF POLITICAL SCIENCE, SREE NARAYANA COLLEGE, KOLLAM & ROTARY CLUB OF QUILON SOUTH

Preamble

This Memorandum of Understanding ("MOU") made on 21/06/2021 between Department of Political Science, Sree Narayana College, Kollam (herein referred to as "SNCK") and Rotary Club of Quilon South (herein referred to as "RCQS") by mutual consent. The SNCK and RCQS, collectively referred to as the "Institutions" or the "Parties",

5. Both Parties agree that prior written approval is required before using the other Party's name, logo, or other Intellectual Property rights in any advertising or associated publicity.

6. This Agreement places no financial obligations or supplementary funding commitments on either Party.
7. This MoU may only be amended or modified by a written agreement signed by the representatives of each Party.
8. This MoU is valid for a period of One year from the date of signing by the authorized signatories of each Party.
